Sealed bids will be received by the Hart County Water and Sewer Authority, Hart County, Georgia (OWNER), for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of the Eagle Grove School Area Water System Extension project in Hart County, Georgia.

Approximately 13,217 L.F. of 8-inch PVC waterline, 3,085 L.F. of 6-inch PVC waterline, 338 L.F. of 8-inch and 6-inch freebores, 240 L.F. of pipeline crossing, 100 L.F. of 16-inch steel casing with 8-inch DIP jack and bore, 15 each fire hydrants, (10) 8-inch gate valves, (2) 6-inch gate valves, (2) Line termination with fire hydrant assembly, approximately 20 service connections and related appurtenances.

Time of completion for all work associated with this project shall be one-hundred-twenty (120) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds\* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "Bid for Eagle Grove School Area Water System Extension for the Hart County Water and Sewer Authority" and be labeled with the BIDDER'S State of Georgia Utility Contractor License Number. If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

The Owner has acquired all local, State and Federal permits in connection with this project with the exception of the EPD, LDA, GDOT, and the Pipeline Crossings permits. These permits will be acquired prior to the Notice to Proceed being executed.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

Surety companies executing Bonds must appear on the US Treasury Department's most current list (Circular 570 as amended) and be authorized to transact business in the State of Georgia. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
