

ADVERTISEMENT FOR BIDS

**West Side Water System Improvements
Contract No. 2 – Escowee Drive Waterline Replacement
for the
City of Helen, Georgia**

Sealed bids will be received by the City of Helen, Georgia (OWNER), for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of West Side Water System Improvements Contract No. 2 – Escowee Drive Waterline Replacement in Helen, Georgia.

Bids will be received at Helen City Hall, 25 Alpenrosen Strasse, Helen, Ga 30545 until 10:00 a.m. on April 28th, 2016. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER and the project will be awarded, if it is awarded, within sixty (60) days of the bid opening. If a bidder is not selected within sixty (60) days of the bid opening, any bidder that is determined by the OWNER to be unlikely of being selected for contract award shall be released from their bid.

The award of this bid proposal, if awarded, shall be based on several criteria, including prices bid, experience in the work proposed, and references. Refer to Article 14 of Section 00100 for criteria and award method.

The Project consists of, but is not limited to the following major elements:

The replacement of approximately 1,380 L.F. of existing 6-inch dia. waterline with approximately 1,170 L.F. of 8-inch dia. PVC waterline, approximately 214 L.F. of 8-inch dia. DIP waterline, (4) each 8-inch gate valves, (1) 6-inch gate valve, (1) fire hydrant, service reconnections, approximately 1,385 L.F. of Pavement Cut and Repair, approximately 60 L.F. of concrete cut and repair, abandonment of existing waterlines, approximately 110 L.F. of bridge waterline hanging and related appurtenances. Also includes upgrades to the Escowee Drive pressure reducing valve vault and a new sodium hypochlorite feed pump.

Time of completion for all work associated with this project shall be ninety (90) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

Copies of Contract Documents, Specifications, and Construction Drawings may be obtained at the office of Engineering Management, Inc., 303 Swanson Drive, Lawrenceville, Georgia 30043, upon payment of a non-refundable cost of \$150.00. Checks shall be made payable Engineering Management, Inc.

OWNER requires a bid bond* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the City of Helen.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "West Side Water System Improvements Contract No .2 – Escowee Drive Waterline Replacement for the City of Helen, Georgia". If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

The City will acquire all State and Federal permits in connection with this project prior to the start of construction.

*** Surety companies executing Bonds must appear on the Treasury Department's most current list (Circular 570 as amended) and be authorized to transact business in the State of Georgia. For Performance Bonds less than \$300,000 an irrevocable Letter of Credit from a bank as defined in**

O.C.G.A. Code Section 7-1-4 may be submitted in lieu of a bond. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
