Sealed bids will be received by the City of Dillard, Georgia (OWNER), for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of the <u>Downtown Water Distribution System in Dillard, Georgia.</u>

Bids will be received at Dillard City Hall, 892 Franklin St., Dillard Georgia until 2:00 p.m. on September 26, 2013. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER and the project will be awarded, if it is awarded, within sixty (60) days of the bid opening. If a bidder is not selected within sixty (60) days of the bid opening, any bidder that is determined by the OWNER to be unlikely of being selected for contract award shall be released from their bid.

The award of this bid proposal, if awarded, shall be based on several criteria, including prices bid, experience in the work proposed, and references. Refer to Article 19 of Section 00200 for criteria and award method.

The Project consists of, but is not limited to the following major elements:

Approximately 4,855 L.F. of 10-inch DIP waterline, 1,215 L.F. of 8-inch DIP waterline, 1,725 L.F. of 6-inch DIP waterline,1,430 L.F. of 2-inch PVC waterline, 110 LF of Freebore, 560 L.F. of Jack and Bore, 3,780 L.F. of Horizontal Directional Drilling with 10-inch DIP, 1,530 L.F. of Horizontal Directional Drilling with 8-inch DIP, 20 each fire hydrants, 18 each gate valves, 6-inch master meter installation with vault and bypass, 6-inch backflow preventer with vault and bypass, service connections and related appurtenances.

Time of completion for all work associated with this project shall be ONE HUNDRED EIGHTY (180) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

OWNER requires a bid bond\* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the City of Dillard.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds\* in the amount of one-hundred percent (100%) of the total bid.

**Each bid must be submitted in a SEALED ENVELOPE**, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "Downtown Water Distribution System for the City of Dillard, Georgia" and be labeled with the BIDDER'S State of Georgia Utility Contractor License Number. If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

Successful Bidder will be required to perform WORK as the Prime Contractor. WORK performed by Prime Contractor shall be at a minimum 30% of the contract value.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

The City has acquired all necessary State and Federal permits in connection with this project except for USDA approval and Georgia Department of Transportation permits. The City will have all approvals and permits acquired within 60 days of the date of receiving bids. The City has acquired 90% of the easements and rights of way in connection with this project and anticipates that all remaining easements and rights of way will be acquired within 60 days of the date of receiving bids.

\* Surety companies executing Bonds must appear on the Treasury Department's most current list (Circular 570 as amended) and be authorized to transact business in the State of Georgia. Contracts for projects exceeding \$100,000 require bonds or cash deposit in escrow assuring performance and payment each in the amount of 100% of the contract cost. Surety shall be in the form of Performance and Payment Bonds. For Performance Bonds less than \$300,000 an irrevocable Letter of Credit from a bank as defined in O.C.G.A. Code Section 7-1-4 may be submitted in lieu of a bond. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
