If a bidder is not selected within fourteen (14) days of the bid opening, any bidder that is determined by the OWNER to be unlikely of being selected for contract award shall be released from their bid.

Installation of ± 230 L.F. of 12 inch DIP, $\pm 4,700$ L.F. of 12 inch PVC, ± 435 L.F. of 8 inch DIP, $\pm 19,940$ L.F. of 8 inch PVC, ± 640 L.F. of 6 inch DIP, $\pm 23,540$ of 6 inch PVC, $\pm 3,450$ L.F. of 2 inch PVC, 345 L.F. of jacking and boring, 880 L.F. of freeboring, 165 L.F. of 6" horizontal directional drilling with fusible PVC. Installation of ± 200 long and short side service connections, Valves, Fire Hydrants and other appurtenances. Implementation of Erosion and Sediment Control Plan.

Time of completion for all work associated with this project shall be <u>Two Hundred and Seventy</u> (270) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

OWNER requires a bid bond* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the Hart County Water & Sewer Authority.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "Bid for Nancy Hart School Area Water System Expansion for the Hart County Water and Sewer Authority" and be labeled with the BIDDER'S State of Georgia Utility Contractor License Number. If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws.

Easements over private property required for construction have not yet been obtained. Installation of waterlines in such easements amounts to less than 10% of the installation. The OWNER asserts that these will be obtained in a timely manner.

The Owner has acquired the local, State and Federal permits in connection with this project with the exception of G.D.O.T., Williams Gas Pipeline, Colonial Pipeline Co. and Georgia Power for the purpose of rights-of-way encroachment.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

Surety companies executing Bonds must appear on the US Treasury Department's most current list (Circular 570 as amended) and be authorized to transact business in the State of Georgia. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
