The Project consists of, but is not limited to the following major elements:

Asphalt overlay of approximately 0.25 miles of Baldwin Heights Road and 0.20 miles of Davison Street. Approximately 0.09 miles of asphalt removal and replacement on Vista Lane. Removal and replacement of sections of roadway on Baldwin Heights Road and Davison Street. Placement of asphaltic concrete open graded crack relief interlayer on portion of Davison Street. Driveway tie-ins. Striping. Construction and permanent grassing of shoulders.
