

NOTICE - REQUEST FOR PROPOSAL

Sealed submittals from construction firms will be received by the City of Baldwin at Baldwin City Hall, 186 US Hwy. 441, P.O. Box 247, Baldwin, GA 30511-0247, until 1:30 PM, legally prevailing time on Thursday, April 28, 2022, for:

City of Baldwin - Church Street, Ivory Drive, and Lenora Lane Roadway Improvements

After the time and in a designated room and place, the names of the Companies submitting proposals will be publicly read. No further information will be read, discussed, or provided until the evaluation of all submittals is completed. No extension of the bidding period will be made other than by a formal written addendum.

The City of Baldwin is soliciting proposals from qualified construction firms for the removal and replacement of sections of asphalt pavement, placement of asphalt open graded crack relief interlayer on a portion of the pavement, and asphalt overlay on Church Street and Lenora Lane and placement of asphalt open graded crack relief interlayer with asphalt overlay on Ivory Drive.

The Project consists of, but is not limited to the following major elements:

Asphalt overlay of approximately 0.21 miles of Church Street, 0.19 miles of Ivory Drive, and 0.05 miles of Lenora Lane. Removal and replacement of sections of roadway on Church Street and Lenora Lane. Placement of asphaltic concrete open graded crack relief interlayer on portion of Church Street and Lenora Lane and all of Ivory Drive. Driveway tie-ins. Striping. Construction and permanent grassing of shoulders.

Time of completion for all work associated with this project shall be forty-five (45) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

A Bid Bond will be required with proposal submission. The successful bidder shall be required to provide a Payment Bond and a performance bond, each in an amount not less than 100% of the total bid amount, at the signing of the contract. Successful bidder will be required to provide insurance in the amount of at least (\$1,000,000.00) one million dollars as required by paragraph 17 of the "terms and conditions" of these documents.

Your submittal must have a signature in its "**original form**". Firms should submit six (6) copies of proposals one which should be marked as 'Original' and five should be marked as 'Copy'.

Proposals that do not clearly outline responses to each criterion may be eliminated from further consideration. Failure to sign your proposal in the 'Original' transmittal letter will force your proposal to be declared as 'non-responsive' and not be considered for award.

No bid may be withdrawn for a period of sixty (60) days after time has been called on the date of opening.
