ADVERTISEMENT FOR BIDS Water System Improvements for Radium Removal for the City of Warm Springs, Georgia

Sealed bids will be received by the City of Warm Springs, Georgia (OWNER), for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of Water System Improvements for Radium Removal in Warm Springs, Georgia.

Bids will be received at City of Warm Springs – City Hall, 3636 White House Pkwy., Warm Springs, GA until 3:00 p.m. on November 13, 2013. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER and the project will be awarded, if it is awarded, within sixty (60) days of the bid opening. If a bidder is not selected within sixty (60) days of the bid opening, any bidder that is determined by the OWNER to be unlikely of being selected for contract award shall be released from their bid.

The award of this bid proposal, if awarded, shall be based on several criteria, including prices bid, experience in the work proposed, and references. Refer to Article 14 of Section 00100 for criteria and award method.

The Project consists of, but is not limited to the following major elements:

Installation and startup of new vertical turbine raw water pumps and associated piping and valve upgrades.

Installation of approximately 100 L.F. of 6" and 8" ductile iron waterline with appurtenances.

Installation of a new fiberglass chemical feed building with chemical feed equipment.

Installation of an inline static mixer with fiberglass enclosure.

Installation of approx. 430 L.F. of 4" filter backwash force main including 50 L.F. jack and bore.

Installation and startup of a containerized radium removal filtration system.

Electrical work associated with new equipment and adaptation of controls to existing equipment.

Installation of 240 L.F. of 4" PVC waterline with 2 service reconnections, existing 2" waterline connection and associated appurtenances.

Time of completion for all work associated with this project shall be one hundred fifty (150) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

OWNER requires a bid bond* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the City of Warm Springs, Georgia.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "Water System Improvements for Radium Removal, Warm Springs, Georgia" **and be labeled with the BIDDER'S State of Georgia Utility Contractor License Number.** If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

Successful Bidder will be required to perform WORK as the Prime Contractor. WORK performed by Prime Contractor shall be at a minimum 30% of the contract value.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

The City has acquired all necessary State and Federal permits in connection with this project except for a permit from the G.D.O.T. for the temporary construction driveway which is currently in process. The City has not acquired an easement needed for connecting the backwash discharge line to the existing City's manhole but anticipates that it will be acquired within 60 days of the date of receiving bids.

* Surety companies executing Bonds must appear on the Treasury Department's most current list (Circular 570 as amended) and be authorized to transact business in the State of Georgia. For Performance Bonds less than \$300,000 an irrevocable Letter of Credit from a bank as defined in O.C.G.A. Code Section 7-1-4 may be submitted in lieu of a bond. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
